Items Manufactured by CPFG

Production lot numbers are nine digits in length: The first four digits indicate production year, the remaining digits are sequential production numbers corresponding to the year-to-date production run.

Stock lot numbers are comprised of a unique manufacturer 3-letter code (for internal manufacturer/supplier identification purposes) followed by the manufacturer's original batch/lot number. Original manufacturer's labels are left on the packaging, and never removed.

System lot numbers are for internal identification purposes. Those are sequential, corresponding to an individual unit or pallet of product.
